

ACTIONS TAKEN BY THE BOARD CONCERNING STAFF RESPONSE TO
DEMANDS AND REQUESTS PRESENTED IN CONNECTION WITH STUDENT WALKOUTS*

ITEM NO. 1, ADMINISTRATORS

Dr. Richardson moved:

THAT it is the sense of this Board that it cannot agree with the first sentence in this item, which reads: "All administrators where schools have a majority of Mexican-American descent students shall be of Mexican-American descent."

Said motion was seconded by Mr. Gardner, and was carried with 4 ayes and 1 abstention.

Regarding the second sentence in this item, Mr. Gardner moved:

THAT the Superintendent be requested to report expeditiously and from time to time on the success of his announced program to train and recruit administrators of minority extraction.

Said motion was seconded by Dr. Nava, and was carried with 4 ayes and 1 abstention.

ITEM NO. 2, ASSEMBLIES

Dr. Nava moved:

THAT this item be referred to the Personnel and Schools Committee for study and report to the Board at the earliest possible time.

Said motion was seconded by Mr. Gardner, and was carried with 4 ayes and 1 abstention.

Dr. Nava indicated his motion implies a report to that committee by the Superintendent and that it applies to senior high schools only.

ITEM NO. 3, BI-LINGUAL PERSONNEL

Dr. Nava moved:

THAT the Board agrees with this request in principle and asks the Superintendent to make a report to the Board regarding the development of programs to this end.

Said motion was seconded by Mr. Gardner, and was carried with 4 ayes and 1 abstention.

ITEM NO 4, BI-LINGUAL INSTRUCTION

Mr. Gardner moved:

THAT this item be referred to the Educational Development Committee.

Said motion was seconded by Dr. Richardson, and was carried with 4 ayes and 1 abstention.

It was understood that in connection with this item, and in all other instances where items are referred to a committee, the committee will have before it the opinions of County Counsel in all areas that are pertinent.

ITEM NO. 5, BUILDING - NEW

Mr. Gardner moved:

THAT this item be referred to the Building Committee.

Said motion was seconded by Dr. Nava, and was carried with 4 ayes and 1 abstention.

ITEM NO. 6, BUILDING - REHABILITATION

Mr. Gardner moved:

THAT this item be referred to the Building Committee.

Said motion was seconded by Dr. Nava, and was carried with 4 ayes and 1 abstention.

It was understood that the Building Committee would review Items Nos. 5 and 6 with the Superintendent and staff.

ITEM NO. 7, CAFETERIA

Dr. Nava moved:

THAT the first sentence in this item, which reads "Improvement of quality and service of cafeteria food for both teachers and students." be referred to the Auxiliary Services Committee.

Said motion was seconded by Mr. Gardner, and was carried with 4 ayes and 1 abstention.

It was understood that the second sentence of Item No. 7, which reads "Student menus should be Mexican oriented.", would be referred to the Superintendent.

ITEM NO. 8, CLASS SIZE

Dr. Richardson moved:

THAT the Board agrees with the first sentence in this item, which reads: "Class size should be reduced so that teachers can be more effective in the classroom and devote more time to individual students.", and endorses as an accurate analysis of the issue the position statement reported by the Superintendent.

Said motion was seconded by Dr. Nava, and was carried with 6 ayes.

ITEM NO. 9, CLEANUP

Dr. Willett moved:

THAT the Board concurs with the position statement reported by the Superintendent.

Said motion was seconded by Mr. Gardner, and was carried with 4 ayes, 1 no, and 1 abstention.

ITEM NO. 10, COMMUNITY RELATIONS

The Board agreed with the Superintendent's response.

ITEM NO. 11, CORPORAL PUNISHMENT

Dr. Nava moved:

THAT this item be referred to the Personnel and Schools Committee.

Said motion was seconded by Mr. Gardner, and was carried with 4 ayes and 1 abstention.

ITEM NO. 12, COUNSELORS

Mr. Gardner moved:

THAT the Board concurs with the position statement reported by the Superintendent.

Said motion was seconded by Dr. Willett, and was carried with 5 ayes and 1 abstention.

ITEM NO. 13, ELECTIVES

Mr. Gardner moved:

THAT the Board endorses the staff response to this item and urges the Superintendent to bring to its attention any further recommendations in this area.

Said motion was seconded by Dr. Nava, and was carried with 5 ayes and 1 abstention.

ITEM NO. 15, FREE PRESS

Dr. Richardson moved:

THAT the Board desires to increase flexibility and freedom in the distribution and availability of printed materials on high school campuses and requests the Superintendent to suggest procedures and policy statements by which this declaration can be implemented.

Said motion was seconded by Dr. Nava, and was carried with 4 ayes and 1 abstention.
